WHEREAS, this Ordinance will allow for the monitoring of Timber Harvest necessary to allow sufficient collection of the Timber Tax; and,

WHEREAS, it is the desire of Ware County, Georgia, to adopt a reporting requirement for the startup of Timber Harvest to allow for compliance with the notices to applicable

WHEREAS, public roads and rights-of-way may be damaged and left unrepaired by persons known and unknown who harvest and transport timber from the site of its

NOW THEREFORE, be it ordained by the Board of Commissioners of Ware County,

SECTION I: This ordinance shall be known as the Timber Harvesting Notification

Ordinance.

SECTION II: Notification To Ware Tax Commissioner

Georgia, and it is hereby ordained as follows:

(a) Any timber harvesting contractor shall give 48 hours telephone notice or 3 day written notification, via E-mail, first class mail, or in person, to the Ware County Tax Commissioner, of where trees ready to be harvested are standing prior to harvesting said trees. Said notice shall be on the following form: [set out form here, or say: Attached as Exhibit A]

(b) If any timber-harvesting operator should elect to harvest more acres than

transmitted to the Ware County Tax Commissioner pursuant to the time frame set out in Section II (a).

SECTION III: PROCEDURE FOR ISSUANCE AND USE OF NOTIFICATION

- (b) The Tax Commissioner shall have authority to suspend any timber harvesting operations should the said operation have a detrimental effect on the County's

This ordinance shall be enforced by the Ware County Tax Commissioner. Citations for violations may be issued by the Ware County Tax Commissioner, including any certified

Any Ordinance in whole or in part in conflict with this Ordinance is/are hereby repealed.
